

## REDLANDS RSL HUT CODE OF CONDUCT.

- 1. All new members shall visit "The Huts" in company with a current senior member only for the first year of their membership. The exception to this rule is that a member may be assessed by the "Hut Coordinator" as demonstrating the ability to operate hut facilities unsupervised.
- 2. Members must sign out and sign in "The Huts" keys at the Redlands RSL front reception close to the dates of visiting and returning. Prior to visiting "The Huts", members will contact the "Hut Coordinator", informing him of their intended stay.
- 3. The member who signs out the "Huts" key shall be held responsible for enforcing the "Procedures and Code of Conduct" of the huts to other members and guests during their visit.
- 4. All members and guests while visiting and staying at "The Huts" shall conduct themselves in a respectful and courteous manner to all other members and guests.
- 5. If members or their guests are accompanied by children, other members and guests shall show consideration and behave in a manner that is acceptable to the child's parent or guardian.
- 6. Fighting or excessive bad language shall not be tolerated and reported to "The Committee"
- 7. Members must follow the opening and closing procedure of "The Huts".
  - a) Members will complete the "checklist form" received with their hut keys and return the completed form with hut keys to the Redlands RSL reception at the completion of their stay.
  - b) Non-members staying overnight at the huts shall be charged \$15 per person per night. Monies will be paid to the hut coordinator or club treasurer at the first available opportunity.
  - c) All members and guests shall keep "The Huts" in a neat and tidy state, removing with them all rubbish accumulated during their visit.
- 8. Under no circumstances are members or their guests allowed to cut/chop down any trees on the island, which include dead trees. Any trees found that may cause harm or danger will immediately advise the "Hut Coordinator", who will take appropriate action.

- 9. Members and guests must take their own supply of firewood for use in the huts; any fires by members must utilise the fire pit provided only.
- 10. Members and guests are reminded to refrain from anchoring directly in front of "The Huts", allowing members and guests to fish and load and unload vessels unhindered during their stay.
- 11. All members are requested to raise and lower "The Australian Flag" on arrival and departure.
- 12. Members must secure the huts if they leave the complex unattended to go fishing for an extended period to maintain security.
- 13. Members and guests will abide by the following:
  - a) Excessively loud music shall not be played at "The Huts" If requested by any member, the volume must be turned down.
  - b) All members and guests shall respect other members' and guests' personal property.
  - c) All members and guests shall not intentionally damage any part of "The Huts" property or equipment.
  - d) All members and guests shall be obligated to make themselves and other members and guests safe and secure while visiting and staying at "The Huts".
  - e) All members and guests shall be obligated to adhere to National Parks & Wildlife, Queensland Fisheries and local Council laws.
- 14. Any member or guest who fails to comply with the "Code of Conduct" may be requested to front the "Committee" to explain their noncompliance, and the "Committee" shall decide on any action necessary, if warranted. Any decision or penalty made by the committee concerning breaches of hut conduct are final and there is no right of appeal.
